MEMORANDUM OF UNDERSTANDING

between

**UNIVERSITY OF VICTORIA,
DIVISION OF CONTINUING STUDIES, ENGLISH LANGUAGE CENTRE, Canada**

and

UNIVERSIDAD DE CUENCA, Ecuador

The University of Victoria, Division of Continuing Studies, English Language Centre (ELC) and the University Institute of Languages, through the Spanish for Foreigners Program at the University of Cuenca (UC), are entering into an agreement related to the delivery of language programming, for the purpose of furthering potential cooperation in both education and academic learning experience. The ELC and UC hereby affirm their intent to explore possible cooperation as will be of mutual benefit to their respective universities. Academic cooperation and exchange is considered here to include but is not limited to:

1. Facilitation of English as an Additional Language programs for students, teachers and staff of the Universidad de Cuenca. A 20% discount will be applied to program tuition for UC participants. Applications must be submitted directly by UC, with no intermediary.
2. Coordination of cultural activities for UC participants, of mutual interest.
3. Exchange of data, documentation, and research materials in fields of mutual interest.

The two Parties agree that this Memorandum of Understanding is not a legally binding document but rather a statement of the common intent to engage in mutually acceptable cooperation to identify potential opportunities for academic cooperation and exchange. Details of the implementation of any particular initiative resulting from this agreement shall be negotiated between the two universities as each specific case may arise, and will result in a separate agreement. Both parties understand that financial arrangements will have to be negotiated and will depend on the availability of funds.

This agreement to promote academic collaboration is valid for a period of 2 years from the date of signing. It is subject to revisions, renewal, or cancellation by mutual consent and becomes effective upon completion of signatures. This agreement has been translated into Spanish, and

while every attempt has been made to render an accurate translation, the English version of this Agreement is binding and supersedes the Spanish language in the event of any discrepancies.


